

Racking four fat runs in the eighth inning, Florida State broke up a scoreless thriller here Saturday afternoon and took its first baseball victory from University of Florida 4-1.

For six innings neither team got a hit as FSU's Jerry Boxer and Florida's Bucky Williams matched each other, pitch for pitch.

Then UF outfielder Charles King snapped the spell with a single to short left in the top of the seventh. In the ninth, King prevented a whitewashing by smashing a second single that brought the Gators' one and only run across.

King's two hits were all that was yielded by Boxer, who struck out 13 and walked four while upping his record to 3-1.

FSU, likewise, managed only two blows but bunched both in that big eighth. The first boy started things off with a walk-off homer forced at home by Bob Howser. Howser also walked later. Coach Howser said.

Boxer then pounded a long one to rightfield. The ball landed in the hands of Bernie Parrish, for a double. Parrish recovered in time to throw home in an effort to nab Rosell, who was rounding third. **ROSELL SCORES**

Rosell rammed into catcher Charles Rawlings, and Rawlings dropped the ball, permitting the first run of the game. The collision was something of a replay of a bit of action Friday night, when Parrish had bowled over FSU catcher Johnny Sheppard as he tried to defend the fort. Sheppard was hurt on the play and had to leave the game, but he was behind the plate again Saturday.

Owen McCarron followed with a fly to left that brought Howser racing in from third after the catch.

UF Coach Dave Fuller jerked Williams in favor of left-hander Tim Twomey as southpaw swinging Casey Hendrix came to bat. The strategy boomeranged as Hendrix drilled a homer over the rightfield fence for two more runs.

Boxer weakened a trifle in the ninth as he hit Dick Marlowe and walked Parrish. King then lashed out for a single that brought Marlowe home.
