

FSU Doubles Team Seeks Crown At Southern Intercollegiate Championship

Play continues on Monday morning

Sept. 25, 2005

ATHENS, Ga.-- Florida State sophomore Sam Chang and his junior partner Jonathas Sucupira advanced to the flight No. 1 semifinals draw at the Southern Intercollegiates Sunday at the Dan Magill Tennis Complex. They will face Jonathan Stokee and Joey Atas of the University of Georgia in one semifinal on Monday, while Scott Blackmon and Zach Rath of Georgia Tech will face Nestor Briceno and Stefan Tell of Florida in the other.

In flight No. 2, the Seminoles' Andrew Bailey and Maciek Sykut will battle Michael Reynolds and Tim Walter of the College of Charleston in one semifinal, while Eduardo Gutierrez and Jacek Twarowski of Georgia State battle Jorge Padilla and Alejandro Portugal of Winthrop in the other.

Chang and Sucupira advanced to the semifinals after defeating **Strahinja Bobusic** and Colin Purcell of the University of Georgia, 8-6. In doubles flight No. 2, Bailey and Sykut upended Cromydas/Sachs (VU), 8-6, during the quarterfinal round.

Play resumes at 9:00 Monday morning with doubles semifinal match. All remaining matches will begin play at 10:30 a.m.

ATHENS, Ga.-- Florida State freshmen Andrew Bailey and Maciek Sykut claimed the 2005 Southern Intercollegiate Championship doubles title in flight No. 2 Monday at the Dan Magil Tennis Complex after defeating Julien Lousao and Olivier Nussbaum of Southeastern Louisiana, 8-5.

In the semifinals round early Monday morning, Bailey/Sykut overpowered the College of Charleston's Michael Reynolds and Tim Walter, 8-4, to advance to the championship match.

The Seminoles' duo of sophomore Sam Chang and junior Jonathas Sucupira also fared well in doubles play over the weekend, advancing to the flight No. 1 semifinals draw Monday after defeating Strahinja Bobusic and Colin Purcell of the University of Georgia, 8-6.

Although they provided a tough showing, Chang/Sucupira came up short, 9-7, to Duke's top doubles team of Jonathan Stokke and Joey Atas.
