### Recap

September 29, 2000

FOUR BULLDOGS ADVANCE TO ROUND OF 16  
One day of Southern Collegiate Championships complete

ATHENS, Ga. Four Bulldogs will play in the round of 16 of their respective brackets on Saturday, as Lesley Joseph, Brandon Wagner and Travis Parrott won their second round matches in Division I. Will Glenn topped seeded player Tristan Menaine of North Carolina in the second round to advance to the quarterfinals of Division II.

Lesley and Wagner, who each had a bye in the first round, played only one game on the first day of competition. Wagner defeated Stetson's Piero Demichelli 6-4, 6-4, while Lesley easily handled Claran Moore from Bethune-Cookman 6-2, 6-4.

Parrott started the day with a 6-0, 6-0 shutout against Pablo Perez-Gras from Georgia State. The junior's second match proved to be more of a challenge. After dropping the first set 3-6, Parrott went on to win the second and third sets, 6-5, 6-3, respectively.

Glenn disposed of Furman's Michael Jacobson, 6-4, 6-0, in the opening round before knocking off Menaine, who was one of the top 16 seeds in the second division, 6-4, 6-5. In his first match, Glenn won eight consecutive games to cruise to victory.

Nicolas Boeker won his first match 6-5 (7), 6-4, over Samford's David Misner, but lost in the second round to a seeded (9-16) player, Willy Campos, 6-4, 6-5 (4). Demetris Leontis followed suit, winning in the first round, 5-6 (7), 6-2, 6-2, against Michal Kwiecier of Winthrop, but losing in the second to Middle Tennessee's Michael Staniak.

Boeker and Leontis will join Todd Carlson, who lost in the first match to Georgia State's John Monk, 0-6, 6-5 (6), 6-3, in the consolation bracket on Saturday. Carlson easily won the opening set, but came from a break down to send the second set into a tiebreak. Carlson lost the tiebreak 8-6 and did not have enough gas to rally in the third set.

Competition continues on Saturday with main draw singles and doubles play and singles consolation. Wagner, Parrott and Joseph will begin action at 9 a.m. at the Dan Magill Complex, with Glenn to hit the court around 9:30 a.m.

THREE BULLDOGS FALL IN QUARTERFINALS OF SOUTHERN COLLEGIATES  
Carlson still competing in consolation draw

September 30, 2000

ATHENS, Ga.-The semifinals of the 33rd Annual Southern Collegiate Championships are set, but unfortunately for Georgia there will be no Bulldogs in action.

Georgia's four players in the main draw exited the tournament during Saturday's play. Todd Carlson is the lone Bulldog with competition remaining, as he advanced to the third round of the Division II consolation draw. Action begins on Sunday at the Dan Magill Tennis Complex with consolation play beginning at 9 a.m., followed at 10 a.m. by semifinals in the first three singles divisions of the main draw. Division IV singles were played on Saturday, and the finals will be Sunday at 10 a.m. The semifinal round of the consolation brackets will begin around noon with doubles quarterfinals to follow.

Brandon Wagner met a challenge in the round of 16, facing the No. 6 seed and SEC foe Ajay Ramaswami from LSU. Ramaswami cruised through the first set, winning 6-1. Both players held serve through six games, but a break gave Ramaswami the 4-3 advantage in the second. A double fault by the Tiger evened the set at 4-all, and both men held serve in the next two games to send the set into a tiebreak. Wagner led the tiebreak 6-2 before three straight points drew Ramaswami to within one at 6-5. An overhead smash gave Wagner the set 6-5 (5). In the third and final set, Wagner was up a break early, but could not hold serve in the 10th game, resulting in another tiebreaker. Ramaswami led 5-3, but three consecutive points by Wagner gave him a 6-5 lead.

The score went back and forth, but another double fault by Ramaswami sent Wagner to the next round with a 1-6, 6-5 (5), 6-5 (11) victory. The question of the day was whether Wagner could knock off two of the top six seeds to advance to the semifinals.

After topping sixth-seeded Ramaswami, Wagner faced the No. 4 seed Xavier Luscan from Florida State. Wagner took the first set, but the Seminole battled back to take the second and send the match to a deciding third set. Luscan was too much to handle in the third set, winning 3-6, 6-4, 6-3. Lesley Joseph also faced a fellow SEC member in the third round in LSU's Daniel Kiernan. Joseph broke Kiernan in the 10th game to win the first set 6-4, but fell behind 3-0 to open the second set. The sophomore battled back and evened the issue at 5-5 heading into a second-set tiebreak. Lesley took the tiebreak 7-1 to win the match and advance to the quarterfinals to face the No. 2 seed Andres Pedroso from Duke.

In the afternoon match, Pedroso proved why he was the second seed. The Blue Devil was too strong for Lesley, winning 6-3, 6-2. After defeating the No. 3 seed Adam Carey Friday night, Travis Parrott had little difficulty disposing of Florida State's Romain Jurd, who was one of the 9-16 alphabetical seeds in Division I. Parrott took the first set 6-1 and jumped out to a 4-1 lead in the second. Parrott moved on to the quarterfinals with the 6-1, 6-2 victory. The score seemed very similar in the next round, but this time Parrott was on the shortside of 6-1, 6-2 decision to Daniel Klemetz of Middle Tennessee.

Closing out third round competition in the main draw, Will Glenn dropped his first set in a tiebreak to Mississippi State's Max Fomine. Glenn battled in the second set, but Fomine was too strong, winning 6-5, 6-4.

Top seeded Mark Parson from Tennessee was knocked out of play by South Alabama's Julien Reynah, 6-3, 6-5 (7). In consolation play, Todd Carlson handed Florida A&M's Kareem Bennett a 6-1, 6-2 loss. He will face Piotr Wawrzyniak from Tennessee Tech tomorrow.

Georgia's two doubles pairs were in action on Saturday, with only one advancing. The combination of Glenn and Demetris Leontis topped Winthrop's Kwiecier and Delgado 8-7 (5). After falling in singles competition, Wagner and Lesley dropped a 8-4 decision to Stetson's Norman and Nicin.

Glenn and Leontis will play in the quarterfinals of the Division II doubles draw on Sunday afternoon.

Leontis and Glenn still alive in doubles play

ATHENS, Ga - With only one day of competition remaining in the 33rd Annual Southern Collegiate Championships, the finals in the Division I singles will feature a pair of alphabetical seeds,

as Julien Raynal from South Alabama and Middle Tennessee's Daniel Klemetz knocked off the No. 4 and No. 2 seeds, respectively, to advance to the final.

South Alabama's Evan Fowler defeated Mark Pellerin of Middle Tennessee to advance to the Division III finals. SEC member Bryan Fisher (LSU) topped Zlatko Stupavasky from South Alabama, 6-5, 1-6, 6-4 in their semifinal. Florida's Trey Johnson defeated Kirk Jackson of Middle Tennessee, 6-4, 6-5 (4), to win the Division IV title.

Todd Carlson, the lone Georgia player remaining in singles competition, fell to Florida's Jeremy Wutzman, 6-4, 6-3. Carlson was leading the first set 4-1, but Wutzman won five straight games to take the set 6-4. In the second set, both men held serve through six games, but Wutzman broke Carlson in the seventh game. Carlson could not get back on track, losing the set 6-3.

**MIDDLE TENNESSEE'S DANIEL KLEMETZ WINS  
SOUTHERN COLLEGIATE CROWN**  
LSU pair takes doubles title

ATHENS, Ga. — Daniel Klemetz from Middle Tennessee University won the Division I singles title at the 33rd Annual Southern Collegiate Championship Monday at the Dan Magill Tennis Complex.

Klemetz's teammate Michael Staniak claimed the Division II draw. The Tiger duo of Sebastain Rutka and Daniel Kiernan won the Division I doubles championship. Klemetz, who defeated second-seeded Andres Pedroso from Duke, 4-6, 6-5 (2), 6-3 to reach the finals, topped Julien Raynal from South Alabama, 6-3, 6-5 (3), for the Southern Collegiate championship. This was the first championship for Middle Tennessee since Anthony DeLuise won the title in 1997.

No matter what team won the Division I doubles championship, LSU's head coach Jeff Brown would accompany the winning team back to Louisiana. He would be alongside the runners-up too, as both pairs in the finals were from LSU. Rutka, who had played in a singles final earlier in the day, combined with Kiernan to win the doubles title against teammates Ajay Ramaswami and Jesse Smatt, 8-2.

In the second singles division, an unseeded player, Michael Staniak from Middle Tennessee, defeated LSU's Rutka. Staniak

won the first set and held on in the second set tiebreak for the 6-3, 6-5 (3) win.

It took three sets to determine a winner in the Division III singles final. LSU's Bryan Fisher took the third and deciding set to defeat South Alabama's Evan Fowler 6-5, 4-6, 6-3.

South Alabama's Christian Thall claimed the Division I consolation with a 6-4, 3-6, 10-7, win over David Wright from Georgia Tech. In the Division II consolation draw, Jeremy Wutzman from Florida defeated LSU's Anthony Matelijan 6-2, 6-0 in the final.

The duo of Will Glenn and Demetris Leontis, who earned a spot in the Division II doubles final, won the division by default. Memphis' doubles finalists Schmulian and Chamberlain were unable to stay until Monday's final.

Several finals that were scheduled for Monday were played at the conclusion of Sunday's competition to enable student-athletes to return to their respective schools by Monday. The combination of Mooney and Bassett from Florida State won the Division III doubles title, 8-7 (3), against Memphis' Magney and Lahie. Wes Nott from Florida defeated Georgia State's Miha Lisac, 6-2, 6-5 (2), in the Division III consolation draw.
