

### FOUR OF FIVE BULLDOGS ADVANCE IN DAY ONE OF SOUTHERN COLLEGIATES

Adam Seri returns to the competition for the first time in over a year

ATHENS, Ga. opening singles match at the 2001 Southern Collegiate Championships at the Dan Magill Tennis Complex in Athens.

Brandon Wagner, who is the fourth seed in the Division I draw, topped Armstrong Atlantic State's Leonardo Matta 6-2, 7-5. Wagner cruised to a 6-2 win in the first set and went up a break

at 3-2 in the second set and went on to take the match in straight sets. Wagner will face Catalin Bradu of Central Florida in the Round of 32 Saturday morning at 11 a.m.

Senior Adam Seri, who was an NCAA singles participant in 2000 but sat out last season due to a shoulder injury, returned to the court and recorded a straight-set victory. The match was on serve at 4-4 when Seri broke Louisville's Cody Conley to go up a break. He won the first set 7-5 and took the second set 6-2. Seri will square off against Renaro Silveria of Georgia Perimeter at 11:30 a.m.

Nicolas Boeker needed three sets to advance to Saturday's play. Boeker took the first set 6-3 against David Ruiz from Mississippi State, but Ruiz evened the match at one set a piece, taking the second set 6-2. Boeker won the third set 6-2 for the victory. Boeker will play top-seeded Michael Kogan of Tulane Saturday at 10:30 a.m.

Ion Vlad rounded out the Bulldog victories as he defeated Stetson's Aleksander Antonijevic in three sets, 6-2, 1-6, 6-0. He will face fifth-seeded Peter Richman from LSU at 9:30 a.m.

The lone Bulldog headed to the consolation draw is redshirt sophomore Todd Carlson. He fell to Piotr Warvzyniak of Tennessee Tech, 6-3, 6-3.

The Georgia doubles teams did not have quite the success as the Bulldogs had hoped. After a first round bye, the duo of Wagner and Boeker fell to UT-Chattanooga's Thomas Knizat and Jason Ontog 9-8 (0). The pair of Carlson and Vlad won its opening match 8-4 against Ricky Echeverri and Subash Patel of Mercer 8-4, but loss to Vanderbilt's Scott Brown and Lewis Smith 9-8 (2) in the second round.

Competition continues on Saturday with main draw singles and doubles play and singles consolation action beginning at 8 a.m.

**DAY 2 (Saturday)****Recap****TWO BULLDOGS REMAIN IN THE 2001 SOUTHERN COLLEGIATE CHAMPIONSHIP**

Brandon Wagner wins a pair of matches to advance to the quarterfinals

ATHENS, Ga. - Adam Seri and Brandon Wagner are the only two Bulldogs still in the hunt for the singles title at the 2001 Southern Intercollegiate Championships at the Dan Magill Tennis Complex in Athens. Both advanced to the singles quarterfinals on Sunday.

Fourth-seeded Wagner topped Central Florida's Catalin Bradu 6-2, 7-5, in the Round of 32 Saturday morning. A crowd assembled on the hill as Wagner battled Kentucky's Jesse Witten, the No. 11 seed, on court five for the evening match. After winning the first set 6-4, Wagner dropped the second 6-0. In the third and deciding set, Wagner, a junior from Tampa, Fla., went up a break at 3-2 and took the final set 6-2 for the victory. Wagner faces ninth-seeded Xavier Luscan from Florida State Sunday morning at 10 a.m.

The other Bulldog playing Sunday is Adam Seri, who won his Round of 32 match against Renaro Silveria of Georgia Perimeter, 6-2, 6-1. Seri was set to face Florida's Hamid Mirzadeh, who was the tenth seed, in the Round of 16, but the Gator withdrew from the singles competition, giving Seri a free pass to the quarterfinals. He will square off against Bobby Reynolds of Vanderbilt at 10 a.m.

Nicolas Boeker departed the tournament after losing a 6-7 (4), 6-0, 7-5 battle to top-seeded Michael Kogan from Tulane. Ion Vlad fell to No. 5 Peter Richman of LSU 6-2, 6-4, in the Division II singles Round of 32. In consolation action, Todd Carlson was trailing Michael Chamberlain of Memphis 6-1, 3-0, when he was forced to retire the match.

#### DAY THREE COMPLETE AT THE SOUTHERN COLLEGIATE CHAMPIONSHIPS

Brandon Wagner the lone Bulldog remaining in the weekend tournament

ATHENS, Ga. - Georgia will have one representative playing Monday at the 2001 Southern Collegiate Championships at the Dan Magill Tennis Complex in Athens. Brandon Wagner topped ninth-seeded Xavier Luscan of Florida State in Sunday's quarterfinals and will face top-seeded Michael Kogan from Tulane in Monday's semifinals at 9:30 a.m.

Wagner, who is the fourth seed in the Division I singles draw, lost his first two service games and fell behind 3-0 in the first set to Luscan in their quarterfinal match. Wagner won three of the next four games to get the set back on serve at 4-3. Both men held, forcing a first-set tiebreak. Wagner lost four of the first six points and faced a pair of set points, trailing 6-4, but the junior from Tampa, Fla., reeled off four straight points to take the first set 7-6 (6).

Wagner took that momentum into the second set, taking a 3-1 lead. A break by the Seminole evened the issue 3-3, and both men held to knot the score at 4-4. Neither player could maintain serve of the next three games, leaving Wagner with a 6-5 advantage and serving for the match. Cramps forced Luscan to retire, sending Wagner into Monday's semifinals.

Adam Seri, who is playing in his first collegiate competition since the 2000 NCAA singles tournament, battled Bobby Reynolds from Vanderbilt in Sunday's quarterfinal match. Reynolds broke Seri in the 11th game to take the first set 7-5. Seri redeemed himself by jumping out to a 3-0 lead and went on to win the second set 6-3. In the third and final set, Seri used an overpowering serve to pick up a break and lead 4-2, but the Commodore would not be outdone. Despite three services aces, Seri was broken in the 10th game to get back on serve, and Reynolds again handled Seri's serve in the final game to win the third set 7-5 and advance to Monday's semifinals.

Competition concludes on Monday with main draw singles semifinals and finals, doubles finals and singles consolation semifinals and finals beginning at 8 a.m.

DAY FOUR COMPLETE AT THE SOUTHERN COLLEGIATE CHAMPIONSHIPS Georgia's Brandon Wagner exits tournament in semifinal

ATHENS, Ga. - Brandon Wagner's quest for the singles crown at the 2001 Southern Collegiate Championships ended with a 6-4, 6-4, loss to top-seeded Michael Kogan from Tulane in Monday's semifinals. All Monday matches were played indoors at the Lindsay Hopkins Indoor Facility due to inclement weather.

In Wagner's semifinal match, one break was all Kogan needed to take the first set 6-4. Wagner came back in the second set with a renewed fire. The junior from Tampa, Fla., picked up an early break to lead 2-0 and went on to lead 4-1 before Kogan started his comeback. Kogan, who is a native of Kfar Saba, Israel, won the next five games to win the set 6-4 and advance to the Division I singles final.

The officials of the tournament got one thing right, as the Division I final saw the top two seeds squaring off. Kogan faced second-seeded Romain Ambert, a sophomore from Mississippi State. Both men stayed on serve throughout the first set, and Kogan managed only two points in the tiebreak as Ambert took a one-set lead. The Bulldog went up a break at 3-2 in the second set but was unable to maintain serve in the final two games to even the match at one set a piece. Frustration and fatigue set in for Kogan, and Ambert rolled to a 6-1 win in the third set to win the tournament title.

For Ambert this was the second tournament crown of his young career at Mississippi State. Ironically, his only other tournament title came in the opening event of last season, winning the Citizen Classic Clay Court Championship. He becomes the first Mississippi State player to win the Southern Collegiate Championship.

The Bulldogs will return to action at the ITA All-America Championship held at the Lincoln Tennis Center at Stone Mountain. Qualifying begins Oct. 9 with the main draw running from Oct. 11th through the 14th.
