FSU OUTSHOOTS APPALACHIAN STATE 24-0 IN FIRST HALF EN ROUTE TO 4-0 SHUTOUT IN HOME OPENER

TALLAHASSEE, FL -- The Florida State women's soccer team (2-0) won it's home opener against Appalachian State (1-2) in a 4-0 shutout. Freshman midfielder Kasey McCall's two first half goals helped the Seminoles to a 3-0 halftime lead.


Freshman midfielder Erin Grimsley started off the scoring at the 20 minute mark with a header off of a cross pass from sophomore forward Alexandra Osorio, as the Seminoles trotted off the field at halftime with a 24-0 shots-on-goal advantage.

Both of McCall's goals were unassisted as she took advantage of two loose ball situations and sailed them in from 21 and 35 yards out, respectively at the 27th and 30th minutes.

Sophomore midfielder Lauren Lynch completed the FSU scoring with an unassisted goal from 20 yards out at the 69th minute.




OPPONENT: Appalachian STATE
